DOZENS OF CARDS REQUIRED TO CARRY

Therefore, they are developed their system accordingly and offering card based authentication to their customers. Even the government/s and other public bodies, agencies also offering electronic cards to their users/citizens. Followings are some type of card which needs to carry with us;

- ATM Card for banking services

- Smart card and Credit card for banking transaction and payment
- Vehicle Registration card – proof of ownership of vehicle
- Driving License Card– Proof of driving license
- Election card – Proof of voter registration
- Employees Identity Card – for identity
- PAN Card – Income Tax Permanent Account Number
- Passport & Visa – for traveling cross border
- Coking Gas Service card
- Electricity Service Card
- Membership Card – Club card, Petro Card, Concession Card
- AADHAR Card – National Identity Card

Front Side of the Card: The front side of the All-in-One Personal Utility Card should have to containing basic and visual information of the card holder i.e. Photo, Name, Gender, Date of Birth, Educational Qualification, Signature, Address, Name of the Employer and Designation. There is need of unique card number which is assigned by the government in India we can use AADHAR card number.

Reaming space of the front side of the card can be used for registration details of the vehicle owned by the card holder i.e. four wheeler details and two wheeler details. Developer of the All-in-One Personal Utility Card can be change the space of the details of registration of the vehicle. Here author has given only example.



Back Side of the Card: Author would like suggest here second side of the card should contain at least photo and name of the card holder. This is an essential to easy identification and authentication. Apart from photo and name of the card holder we can add the details about Bank Account for ATM Transaction, Smart Card, PAN Card, Passport and driving License etc.

Specific Location of the Items: there is very important issue regarding the location of the specific item and identification details. Especially which details will be accessed or read through the electronic system the location of that point should be fixed for all cards. Therefore, the size and dimensions of All-in-One Personal Utility Card should be standardized; any little change may create problem in accessing the card details. More specifically location of MICR strip of the ATM details, chip of the smart card, chip of the vehicle registration details, Passport Card, chip of the driving license details should be fixed for all cards will be issued under All-in-One Personal Utility Card scheme.

Need of Modification in Card Readers: More importantly the readers of the specific card details also need to change accordingly. Because, when we change the formal location of the chip we should change the location of data reader installed in the machine. Here one of the important questions will be arrived that there is need of change old machine or change old card reader installed in machine. Cost of this

replacement may be bear by the service providers or transferred to users.

What Issues and Problems will be Arises?

No doubt, there may be many problems and issues will be creates when this invention be undertaken and implemented. But this is requirement of the any person who has bored from this multiple card system and problems of handling these cards.

1. Who Should Print the Basic Card: There is need of unique printing authority for printing the All-in-One Personal Utility Card for mentioning standardization and security aspects of these cards. More importantly public sector printing agency can be do this

2. How it is Implemented: The government and private agencies that are providing card based services and authentication process they should come together and decide the procedure and method of implementation of this card. Who want to participate in this system they should pay for developing cards, further this cost may be shifted to the customers or users/beneficiaries.

3. When All-in-One Personal Utility Card will Miss: It is also one of the important issues, when this card will miss or forgot at home of office you cannot use any of the service which enabled by this card. If you miss this card you will miss all of the identities and authentication tools which given by your service providers. This is one of the dangers of All-in-One Personal Utility Card.

4. Issues Regarding Password and PIN: All-in-One Personal Utility Card is one unique card but there is separate password and PIN for separate services. System designer can develop double password system for All-in-One Personal Utility Card. First password for enter in to All-in-One Personal Utility Card and others for particular services which may separate for ATM, Smart Card etc.
