

OTOMASYONUN SOSYAL VE EKONOMİK YÖNLERİYLE İLGİLİ BİBLİYOGRAFYA

Bu bibliyografya, "Milletlerarası Çalışma Teşkilâtı" (International Labour Organisation) tarafından "clearing-house" programı çerçevesinde, otomasyon ve ileri teknolojinin sosyal ve ekonomik cepheleriyle ilgili olmak üzere milletlerarası sahada yapılmış yayımlardan derlenmiş bulunan periodik bibliyografyadan, yeniden gözden geçirilmek suretiyle tertiplenmiştir.

M.C.T., otomasyonun ekonomik ve sosyal cepheleriyle ilgili kitap, makale, rapor vs. gibi bütün neşriyatı toplamak ve bu malzemenin herbirinin konusu ve mahiyeti hakkında kısa bir özet hazırlamak suretiyle bunları her altı ayda bir muntazaman "International Labour Review" da yayınlamaktadır. Bu bibliyografya, adı geçen derginin 1966-1968 (Aralık) devresini kavrayan, sekiz nüshasından toplanmış olup tarafımızdan soyadlarına, kitap ve makale nev'ine göre yeniden tasnif edilmiştir*.

Bu bibliyografya'da zikredilen kitap ve makaleler, mümkün olduğu kadar, bu sahada yeni bilgi ve orijinal tahlillerle ilgili konulara yer verenler arasından seçilmiş olmakla beraber, ülkelerin ve kaynakların geniş tutulmasına da gereği kadar önem verilmiştir. Adı geçen bibliyografyanın diğer bir özelliğini de, elden geldiği derecede otomasyonun ekonomik ve sosyal cephelerine değinen yayınlara inhisar ettirilmiş olması teşkil etmektedir.

Bu itibarla işletme organizasyonu, otomasyonun teknik cephesi vs. gibi konular, ancak otomasyondaki gelişme ve tatbikatın ekonomik ve sosyal yönlerine temas ettiği nispet ve derecede ele alınmakta, aksi halde konu dışı tutulmaktadır. Ayrıca işgücü politikası, meslekî eğitim ve eğitim plânlanması vs. gibi sosyal meselelerle ilgili neşriyat da, ancak otomasyonla doğrudan doğruya alakası olduğu takdirde, bibliyografya'ya dahil edilmiş bulunmaktadır.

Otomasyon konusunda neşredilen bu kitap ve makalelerin özetlerinden faydalanabilmek ve bunların esas kaynaklarına baş vurmanın zahmete değip değmediği hususunda karar verebilmek için, dipnotta gösterilen mecmua nüshalarına bakmak gerekmektedir.

Bunun dışında 1966 yılına kadar olan devreyi kavramak üzere, M.C.T. aynı konuda 1300 den fazla kitap, rapor ve makaleyi ihtiva eden bir bibliyografya da yayınlamış bulunmaktadır**.
